POLICE DEPARTMENT JULY MONTHLY REPORT

INCIDENTS OF NOTE:

*2017 Maple City Street Machines Car Show-Monmouth has a large influx of people in a short period of time on the day of the car show. STAFF TRAINING:

*Sgt. Bratcher and I attended the Regional Office of Education Emergency Operations Plan Meeting. The purpose of this meeting was to bring together district wide Emergency Operation Plan teams with emergency response personnel to discuss the form, function and content of school emergency operation plans. The meeting provided an opportunity for collaboration between district emergency operation plan teams and local emergency response providers. Agencies in attendance were MPD, MFD, Warren Co. Sheriff’s Department, Galesburg Police Department, Illinois State Police, and representatives of Henderson, Knox, Mercer and Warren County schools.

*TCO Jamie Horner was one of two recipient’s state wide, of the Gregg Riddle Memorial Scholarship to attend the Illinois Public Safety Telecommunications annual training conference in November. TCO Horner applied for the scholarship which covers hotel costs, conference registration costs and travel. The selection committee valued her interest in public safety telecommunications and the efforts she has put forth to improve her knowledge and involvement in the 911 community. The knowledge gained by TCO Horner’s attendance at the conference will greatly benefit the Department and the City of Monmouth.
